This year's Joint Tour will be held in the Athens, Texas area. The **opening date of the tour is Thursday, September 15** and the **closing date is Sunday, September 18**. Check-in time at the hotel is 3:00 PM, and tour packets will be available in the lobby. Dinner Thursday evening will be on your own, and a traditional get acquainted Ice Cream Social will be provided at the hotel that evening at 7:00 PM. We will be driving mostly on the back roads of this beautiful east Texas countryside. Bring your VCCA Touring Passport. Bring your lawn chairs for the picnic on Friday.

The **registration cut-off date is August 15, 2011**. Registration Fee is **\$60.00 per person**. Expenses covered by the Registration Fees are: admissions to the Texas Freshwater Fisheries Center, East Texas Arboretum, lunch Friday, lunch Saturday, and the Farewell Banquet on Saturday night.

CANCELLATION POLICY: Prior to cut-off date, Registration Fee will be fully refunded. After cut-off date, Registration Fee will be refunded except for some obligated expenses already incurred. Refund decisions will be made by the Tour Master.

Make your hotel reservations anytime between now and August 15, 2011. The host hotel is **Holiday Inn Express**, 1119 East Tyler Street, Athens, Texas 75751; **phone 903-675-2500**. To receive the special group rate, identify yourself as being with the **Vintage Chevrolet Club (VCCA)**. The Special Group Rate is \$85.00 + tax per night for rooms with King or two Queen Beds and includes a hot breakfast buffet.
